# GRANT AID APPLICATION GUIDE

## STEP-BY-STEP PROCEDURE



### GENERAL INFORMATION:

50% funding is available for all ASA/UKCC teaching and coaching courses and for all disciplines, level one and above.

On receipt of the completed application form, your application will be assessed for eligibility. Successful applicants will then receive Notification of the Grant to be awarded.

When the course has been completed, you will need to send the completed 'Notification of Grant Aid' form back to the ASA West Midland Regional Office with a receipt for the course fee attached.

When this is received and has been processed, your club will receive a cheque for the agreed amount directly from the ASA West Midland Region. Please note that the cheque will be made payable to the club, not to the individual.

### PLEASE NOTE:

The ASA West Midland Region is not in a position to provide double funding for grant applications. All sources of funding will be taken into account prior to determining the amount of funding to be awarded.

**Applications must be received prior to the commencement of the course.**

Clubs are encouraged to apply for funding through their County Sport Partnership, where applicable.

The Region retains the right to offer less than the maximum amount, depending on current budgetary constraints.

Please note that:

1. Grant Aid is only available for candidates belonging to Swim 21 accredited clubs or clubs 'working towards Swim 21 accreditation'.
2. Grant Aid is available for tutorial and assessment fees only. No grant aid is available for travel, accommodation or subsistence.
3. Grant Aid does not become payable until a course has been completed.
4. Grant Aid is not allocated retrospectively.
5. Grant Aid is only available for ASA / UKCC courses.
6. Grant Aid is not available for Helper courses.
7. All grants are paid to clubs through the club secretary, no grant aid funds are paid directly to applicants.
